The Aged Care Officer will be expected to take on an Aged Care specialist role in relation to a number of core activities and will act as a specialist resource support person to internal and external stakeholders.

As a result of the Royal Commission into Quality Ageing and Safety, Gippsland PHN received funding for a number of aged care initiatives. These programs include The Care Finder program, Early intervention programs and support for Residential Aged Care Facilities (RACF) in Gippsland with after-hours action planning and processes. The aim of this funding is to provide specialist assistance to senior Australians who require support to access relevant aged care health services.
